**Please note if you have registered your land in past years, you must now RE-SUBMIT your application to continue in the Agriculture District Program.**

**Benefits Include:**

- **No cost**
- **Protection from nuisance suits involving normal farming activities**
- **Some protection from local eminent domain condemnation**
- **You do not have to be a full time farmer to join**
- **Land can be field, pasture, forest or woodlot**
- **You can sell or subdivide any land at any time**

To qualify you must have a minimum of ten acres or a minimum of five acres adjoining a ten acre parcel in the Agricultural District.
