## PRESS RELEASE FOR APRIL 17, 2018

### Driving Under the Influence of Alcohol and/or Controlled Substance

On March 17, 2018 at 21:54 hours, Hilltown Police stopped a vehicle in the 800 block of Bethlehem Pike for erratic driving. The driver verbally provided a name and date of birth which was later determined to be false. The driver was eventually identified as Timothy Louis Price, 45, from the 300 block of Ridge Road, Telford, PA. Price displayed indication of alcohol impairment and failed a series of field sobriety tests. Price refused a blood test, and was taken into custody for active arrest warrants out of Montgomery County. Price was charged with Driving Under the Influence of Alcohol, Providing False Identification to Law Enforcement, Driving While Operating Privilege is Suspended- DUI Related, Careless Driving, and Registration and Certificate of Title Required.

On March 17, 2017 at 09:38 hours, Hilltown Police responded to the area of 1515 Bethlehem Pike for the report of an erratic vehicle. Police located that vehicle in the Walmart parking lot occupied by the driver, identified as Alexis Lynn Bouklis, 27, from the 1700 block of Lower Rocky Dale Road, Green Lane, PA. Bouklis displayed indications of controlled substance impairment, and failed a series of field sobriety tests. Bouklis refused a blood test, and was charged with Driving Under the Influence of Controlled Substance, Operation Following Suspension of Registration.

On March 09, 2018 at 04:03 hours, Hilltown Police responded to the scene of a single vehicle traffic accident on Applewood Drive near Walnut Street. The driver was identified as Paul James Maiers, 39, from the 100 block of Blueberry Court, Perkasio, PA. Maiers displayed indications of alcohol impairment and failed a preliminary breath test. Maiers was placed under arrest and transported for a blood test which later revealed a 0.213% BAC. Maiers was charged with Driving Under the Influence of Alcohol, Careless Driving, and Driving Vehicle at Safe Speed.

### Possession of Controlled Substance

On March 24, 2018 at 22:57 hours, Hilltown Police stopped a vehicle on Route 309 near Hilltown Pike for a suspended registration. The driver was identified as Demetrius Kendrick Alexander, 21, from the 4600 block of Griscom Street, Philadelphia, PA. Police detected controlled substance within the vehicle. The vehicle was subsequently search and controlled substance was located and seized. Alexander was charged with Possession of Controlled Substance, Possession of Drug Paraphernalia, Required Financial Responsibility, Operation of Vehicle Without Official Certificate of Inspection.

On March 10, 2018 at 18:00 hours, Hilltown Police responded to Wawa, 3520 Bethlehem Pike, for a vehicle lockout. Police responded and opened the vehicle at the vehicle owner's request. Upon opening the vehicle, Police immediately detected the presence of a controlled substance. Police determined the controlled substance belonged to a passenger within the vehicle. The passenger was identified as Jayden Noel, 18, from the 100 block of Fairview Avenue, Perkasio, PA. The substance was seized, and Noel has been charged with Possession of Controlled Substance.

On January 31, 2018 at 15:43 hours, Hilltown Police stopped a vehicle in the 100 block of Main Street in Silverdale for an expired vehicle registration. The driver was identified as Jason Anthony Hart, 26, from the 1600 block of Latch String Lane, Hatfield, PA. Police detected the presence of controlled substance emanating from within the vehicle. The vehicle was searched and controlled substance was found within. Hart has been charged with Possession of Controlled Substance, Possession of Drug Paraphernalia, Driving While Operating Privilege is Suspended, and Registration and Certificate of Title Required.

On March 26, 2018, Hilltown Police responded to Cherrywood Court for the report of a disturbance. Police made contact with the actor who was identified as Antone Gonsalves, 70, from the 300 block of Cherrywood Court, Perkasio, PA. Gonsalves was in possession of suspected controlled substance, and was subsequently charged with Possession of Controlled Substance, and Possession of Drug Paraphernalia.

### **False Identification to Law Enforcement**

On March 1, 2018 at 16:11 hours, Hilltown Police stopped a vehicle in the 700 block of Route 113 for an expired registration. The operator at the time of the stop provided a false name and date of birth. After a lengthy and continued investigation, Police determined the true name of the driver as being Juan Gabriel Paez-Ricalday, 43, from the 400 block of North 2<sup>nd</sup> Street, Souderton, PA. Paez-Ricalday was charged with False Identification to Law Enforcement, Drivers Required to be Licensed, and Operation of Vehicle Following Suspension of Registration. Paez-Ricalday was video arraigned before Judge Michael Petrucci, from Newtown and committed to the Bucks County Correctional facility in lieu of posting 10% of \$30,000.00 bail.
