## ORDINANCE NO. 98-12

AN ORDINANCE OF THE TOWNSHIP OF HILLTOWN, COUNTY OF BUCKS, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE ZONING ORDINANCE OF HILLTOWN TOWNSHIP, AS AMENDED, (THE "ZONING ORDINANCE") BY AMENDING PERMITTED USES IN THE LI AND PC-1 TO INCLUDE MOBILE HOME PARKS AND AMENDING THE AREA AND BULK STANDARDS FOR B6, MOBILE HOME PARK AND B4, PERFORMANCE SUBDIVISION TO PERMIT THEIR USE ON TRACTS OF 10 ACRES OR GREATER.

SECTION 1. SECTION 2. The Hilltown Township Zoning Ordinance of 1995, as amended, and its zoning map and classification, is hereby amended and changed to reclassify the following Bucks County Tax Parcel Numbers from RR-Rural Residential to PC-1 Planned Commercial: 15-032-003 and 15-032-004.

SECTION 3. Section 406C13(2), Nursing Home, is hereby amended as follows:

2. A lot area of not less than five (5) acres shall be required within the PC-1 District.

<u>SECTION 4</u>. If any part of this Amendment to the Zoning Ordinance of Hilltown Township shall be held to be invalid or unconstitutional, the remaining provisions of this Amendment shall remain in full force and effect.

SECTION 5. This Ordinance shall take effect five (5) days after enactment.
