ORDINANCE 82-3

AN ORDINANCE AMENDING HILLTOWN TOWNSHIP ORDINANCE 72-2, ENACTED AND ORDAINED DECEMBER 4, 1972, RELATING TO SANITATION AND THE PROMOTION OF PUBLIC HEALTH AND SAFETY; PROVIDING FOR THE COMMERCIAL DISPOSAL OF REFUSE PRODUCED IN THE TOWNSHIP OF HILLTOWN; REGULATING THE COLLECTION AND DISPOSAL OF SUCH REFUSE; PROVIDING FOR THE MAINTENANCE OF SANITARY CONDITIONS ON PUBLIC AND PRIVATE PREMISES WITHIN THE TOWNSHIP; PROVIDING FOR THE LICENSING AND REGULATION OF COLLECTORS OF REFUSE AND PROVIDING PENALTIES FOR VIOLATION OF THIS ORDINANCE.

BE IT ENACTED and ORDAINED by the Hilltown Township
Board of Supervisors, Bucks County, Pennsylvania, that the
above mentioned Amending Ordinance will be adopted as stated
below:

- 1. Article I, Section (a) is amended to read as follows:
- (a) "garbage" means the animal and vegetable waste resulting from the handling, preparation, cooking and consumption of food.
- 2. Article II, Section (1) is amended to read as follows:
- Section 1. The transportation of refuse into the Township of Hilltown from without its boundaries for the purpose of accumulating, burying, processing, burning or destroying said refuse within the said Township is hereby declared

to be unlawful. Except, that refuse may be deposited at a State regulated landfill or incinerator; providing that all the rules and regulations relating to the operation of such landfill or incinerator are fully complied with.

- 3. Article IV, Section (3) is amended to read as follows:
- Section 3. Licenses shall be issued for the calendar year, or that part of the year which has not elapsed at the time the license is granted. The license fee shall be set by Resolution of the Board of Supervisors.
- 4. Article IV, Section (4) is amended to read as follows:
- Section 4. Before the issuing authorities shall issue any license, the applicant shall file with Township proof of public liability coverage of all vehicles to be licensed, in the amount of \$25,000.00 for property damage for one claimant, and \$50,000.00 for one accident, and \$500,000.00/\$1,000,000.00 bodily injury liability.
 - 5. Effective Date This amending Ordinance shall

take effect and be in force	(5) days after it is adopted
by the Hilltown Township Bo	ard of Supervisors.
