

ORDINANCE NO. 82-9

AN ORDINANCE AMENDING THE HILLTOWN TOWNSHIP ORDINANCE NUMBER 64-3 OF AUGUST 15, 1964, AS AMENDED BY ORDINANCE NUMBER 75-4, OF OCTOBER 13, 1975, AS AMENDED BY ORDINANCE NUMBER 77-4, OF DECEMBER 12, 1977 ESTABLISHING STOP INTERSECTIONS WITHIN THE TOWNSHIP OF HILLTOWN, COUNTY OF BUCKS AND STATE OF PENNSYLVANIA BY ADDING FOUR (4) NEW LOCATIONS FOR STOP SIGNS TO THOSE ALREADY PROVIDED FOR.

BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Hilltown Township, Bucks County, Pennsylvania, and it is hereby Enacted and Ordained, by authority of the same that the Section 1 of Ordinance number 64-3 of August 15, 1964 as amended by Ordinance number 75-4 Section 1, as amended by Ordinance 77-4 Section 1, is hereby amended by the following to read:

SECTION 1.

(ee) Northbound traffic on Conestoga Way, Township Road No. \_\_\_\_\_, shall stop at its intersection with Reliance Road, Township Road No. 404.

(ff) Southbound traffic on Conestoga Way, Township Road No. \_\_\_\_\_, shall stop at its intersection with East Summit Street, Township Road No. 427B.

(gg) Northbound and southbound traffic on Conestoga Way,

Township Road No. \_\_\_\_\_, shall stop at its intersection with private driveways known as Reliance Square and Reliance Circle, located 500+ feet south of the Conestoga Way intersection with Reliance Road.

(hh) Traffic on all private drives intersecting Conestoga Way within the Green Meadows Development Corporation Subdivision, Sections I, II and III, as shown on the final Subdivision Plans dated November 2, 1972, shall stop at their intersections with Conestoga Way. Private drives are known as: (1) Washington Sqaure; (2) Washington Court; (3) Washington Plance; (4) Reliance Place; (5) Reliance Square; (6) Reliance Circle; and (7) Reliance Court.

Effective Date- This amending Ordinance shall take effect and be in force (5) days after it is adopted by the Hilltown Township Board of Supervisors.
