AN ORDINANCE OF THE TOWNSHIP OF HILLTOWN, COUNTY OF BUCKS, STATE OF PENNSYLVANIA, AMENDING THE 1959 ZONING ORDINANCE AND ZONING MAP FURTHER REVISED AS OF NOVEMBER 1970 OF THE SAID TOWNSHIP BY CHANGING THE ZONING FROM R-50 RESIDENTIAL THAT LAND FRONTING ON ROUTE 313 FROM ROUTE 113 TO STUMP ROAD TO HIGHWAY-COMMERCIAL, C-H DISTRICT, WITH A MAXIMUM DEPTH OF 300 FEET, AND TO AMEND THE ZONING MAP ACCORDINGLY.

## ORDINANCE NO. 73-1

BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Hilltown Township, Bucks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by authority of the same:

SECTION 1. The Zoning Ordinance of the Township of Hilltown, Bucks County, Pennsylvania, and the Zoning Map, a part thereof, as enacted and adopted October 30, 1959, and as further revised November 1970, be and hereby is further amended as follows:

(a) Classification of the Zoning Map which shows the land on the west side of Route 313 from the south side of the intersection of Route 113 extending southward on the land fronting on Route 313 from the aforesaid Route 113 to the north side of Stump Road is hereby changed from R-50 Residential to Highway-Commercial, C-H District, and the maximum depth is 300 feet from Route 313.

SECTION 2. All provisions of the Zoning Ordinance not consistent with this amendment shall likewise be amended consistent herewith.

SECTION 3. This Ordinance shall become effective five

(5) days after acceptance of the same.
