HILLTOWN TOWNSHIP BOARD OF SUPERVISORS REORGANIZATION MEETING Monday, January 3, 1994

The 1994 Hilltown Township Reorganization Meeting opened with the Pledge of Allegiance at 7:40PM.

Supervisor Bennington announced the swearing in ceremony to be performed by District Justice Robert Gaffney for Mr. William Bennett as Township Supervisor, Mrs. Alice Kachline as Tax Collector, and Mrs. Marguerite Walton as Township Auditor.

- A. <u>SELECTION OF TEMPORARY CHAIRPERSON:</u> Motion was made by Supervisor Bennington, seconded by Supervisor Fox, and carried unanimously to appoint Supervisor William H. Bennett, Jr. as Temporary Chairperson.
- B. <u>SELECTION OF TEMPORARY SECRETARY:</u> Motion was made by Supervisor Bennington, seconded by Supervisor Fox, and carried unanimously to appoint Lynda Seimes as Temporary Secretary.
- C. <u>CALL TO ORDER:</u> The Hilltown Township Board of Supervisors Reorganization Meeting of January 3, 1994 was called to order. In attendance were Supervisor William H. Bennett, Jr., Supervisor Kenneth B. Bennington, Supervisor Jack C. Fox, and Mr. Bruce G. Horrocks, Township Manager.

Supervisor Bennett introduced Mr. Bob Gafney, the newly elected District Justice, who is based in New Britain, and serves New Britain Township, New Britain Borough, Silverdale Borough, Hilltown Township and Chalfont Borough.

D. <u>OFFICER ELECTIONS:</u> Nominations were made for the positions of Chairman and Vice-Chairman of the Board of Supervisors.

Motion was made by Supervisor Bennington, seconded by Supervisor Fox, and carried unanimously to appoint Supervisor William H. Bennett, Jr. as Chairman of the Board of Supervisors for 1994.

Motion was made by Supervisor Fox, seconded by Chairman Bennett, and carried unanimously to appoint Supervisor Kenneth B. Bennington as Vice-Chairman of the Board of Supervisors for 1994.

E. <u>OFFICER APPOINTMENTS:</u> Nominations were made for the positions of Township Secretary and Treasurer for 1994.

- S. <u>APPROVAL OF CURRENT PAYABLES</u> Chairman Bennett presented a Bill's List dated January 3, 1994, totalling \$59,516.59. The major item in this Bill's List is a transfer from the Capital Projects Fund on a repayment loan basis.

Motion was made by Supervisor Fox, seconded by Supervisor Bennington, and carried unanimously to approve the Bill's List dated January 3, 1994, subject to audit.

T. MANAGER'S REPORT - Mr. Bruce Horrocks -

- 1. For the Board's signature following this meeting, Mr. Horrocks presented the labor agreement with the police bargaining unit which has been signed, authorized, and attested by the police.
- 2. Mr. Horrocks presented the year end Treasurer's Report with the following balances:

General Fund Checking Account	\$ 16,603.09
Payroll Checking Account	\$ 255.04
Fire Fund Checking Account	\$ 70,521.09
Debt Service Checking Account	\$ 8,359.75
State Highway Aid Checking Account	\$ 64,999.69

For the Board's information, Mr. Horrocks advised the total revenues in the General Fund only for 1993 totalled \$2,340,627.00, and total expenditures in the General Fund only in 1993 totalled \$2,427,713.00, which leaves a variance to the negative of \$87,086.00 for 1993. Contributing to that was permit fees such as zoning, building, electrical, plumbing, signs, use and occupancy, mechanical were down over \$68,000.00, or a 48% shortfall. With regards to expenditures, the two largest items over budget were dental coverage and hospital coverage totalling approximately \$84,000.00 over budget.

Motion was made by Supervisor Fox, seconded by Supervisor Bennington, and carried unanimously to accept the year end Treasurer's Report for 1993, subject to audit.

3. Mr. Horrocks presented linens for signature for the Hilltown Meadows Subdivision, following this meeting.
