1. Manager (JHS):

- -- Meeting in Devon, PA with post office authorities on 9/28/89 at 1:30 P.M. RHG and JHS will attend; BK, WHB and CJM will advise. Will leave at 12:00 Noon; RHG will attempt to rent a mini-van.
- -- Leismeister request for speed limit check on Upper Stump Road. JHS check with New Britain Township regarding speed study.
- -- Letter received from Earl Smith regarding towing of trucks on Keystone Drive; will be discussed at meeting.
- -- Codification of Ordinances FXG will report.
- -- Community Development \$3,500 additional funding available. Hearing to be scheduled for proposals.

2. Zoning/Building (CR & CJM):

- -- Kepich Land Development plan has been filed and signed by Mr. Kepich and Mr. Pileggi.
- -- Savich (Old Bethlehem Road) and Tronco (Blue School Road) will be sent violation letters.
- -- Mrs. Moore, 212 S. Perkasie Rd. Code Enforcement Officer to locate pool permit (from 4 years ago).
- -- Clarification to be made at meeting tonight regarding positions of:

Building Inspector/Zoning Officer - Clarence Radcliff and Code Enforcement Officer - Clarence J. Myers (part-time basis). Zoning Officer will sign Use & Occupancy Permits. Violation letters to be sent by Clarence Myers. RHG suggested sections be highlighted with specific violation; JHS suggested letter could be modified to list specific violation.

3. Engineer (CRW):

- -- Randy Miley, Habitations Offered \$2,000 donation to DARE program in lieu of sidewalk installation.
- -- Debbie Henry CRW meeting with J.Garis and Ms. Henry regarding grading problem in back yard.
- -- PC recommended number of plans for approval: Bridle Run (preliminary); Bricks Villa (preliminary) and Toth (preliminary).
- -- Hilltown Industrial Park RHG requested a status report.
- -- Habitations WHB requested copy of Intex study; GGN will supply.

4. Solicitor (FXG):

- -- Habitations copy of letter received from HTWSA with recommendations for individual wells to be tested all at one time.
- -- Alvarez J.Fox and Wm. Godek questioned decision at last meeting. Decision that there was no intent of abandonment was made by the Zoning Officer.
- -- Planning Commission meetings JHS will send letter requesting that these meetings be taped.
- -- Height of berms at Quarry (Mr. Godek's question from last meeting) in conformance with the Zoning Ordinance.
- -- Church Road Supervisors will look at open space on 9/28/89, prior to meeting in Devon.
- -- Park & Recreation question regarding disposal of township owned property; JHS will discuss with FXG and CRW.
- -- Codification of Ordinances first proposal received from General Code Publishers (\$10,000). FXG will meet with another company (Penn Valley) to obtain another price.
- -- Bux-Mont law suit -- conference to be held between attorneys and judge this week. FXG will report back.
- -- Line Lexington Sewer Agreement still in progress.
- -- Peddling Ordinance given to FXG for his review.

- 5. Roadmaster (TB):
 - -- Hagele, Skunk Hollow Road TB will handle.
 - -- Signs Road Crew has started signing Orchard Road. Blooming Glen Road 45 mph signs are backordered.
- 6. Chief of Police (GE):
 - -- Speed study for Blooming Glen Road Rt. 113 to Dublin Road.
 - -- Pleasant Meadows Speed Study partially completed; each street must be done. "Watch Children" signs will be installed (residents have agreed to pay for "children" signs).
 - -- Rt. 152 to Callowhill TB recommended speed study be performed on that section; residents have requested 45 mph; may be too fast; two hazardous corners.
 - -- Road crew will work on cement floor in maintenance building for storage of salt.
 - -- Bypass Road speed study performed; 40 mph recommended speed.
 - -- Overtime necessary for last two weeks to cover shifts; murder trial; DUI trials.
- 7. Secretary (GGN):
 - -- Any outstanding Newsletter articles should be submitted within next week.
 - -- Still awaiting quote from BCPC regarding maps for Zoning Ordinance.
- 8. Supervisor's Comments/Questions (RHG; WHB):
 - -- RHG questioned purchase order system. JHS reported that a meeting was held with staff explaining proper way to complete p.o. forms. At present time there is a hold on all purchasing due to cash flow. In emergency situations, p.o. # must be obtained from JHS (unless in middle of night or on weekend).
 - -- BCATO Semi-Annual Convention to be held Thursday, 10/19/89; spouses invited. RHG and WHB indicated they would attend with spouses. GGN will check with others and send in reservations.

- -- House numbers WHB recommended they be available at township building at a cost of 25¢ per number; notice will be placed in newsletter.
- -- Rimiro JHS reported averaging \$11,780/3 month period.
