- A. <u>SELECTION OF TEMPORARY CHAIRMAN:</u> The Board selected Robert H. Grunmeier as Temporary Chairman in order to conduct the meeting prior to nominations.
- B. <u>SELECTION OF TEMPORARY SECRETARY</u>: The Board selected Gloria Neiman as Temporary Township Secretary for the purpose of taking minutes prior to nominations.
- C. CALL TO ORDER: The Hilltown Township Board of Supervisors' Reorganization Meeting of January 3, 1989 was called to order by Temporary Chairman, Robert H. Grunmeier at 7:30 P.M. Mr. Grunmeier announced that, as in the past, there would be no public comment at this meeting. In attendance were: Supervisors Robert H. Grunmeier, Betty J. Kelly and William H. Bennett. Also in attendance: James H. Singley, Gloria G. Neiman, Chief George Egly and Thomas Buzby.
- D. <u>NOMINATIONS</u>: Nominations were made for Chairman and Vice Chairperson of the Board: Motion was made by Mrs. Kelly to nominate Robert H. Grunmeier as Chairman; motion seconded by Mr. Bennett and carried unanimously. Motion was made by Mr. Grunmeier to nominate Betty J. Kelly as Vice Chairperson; motion seconded by Mr. Bennett and carried unanimously.
- E. <u>PERSONNEL APPOINTMENTS</u>: The following motions were made by the Board for Township officers/employees:
- 1) Township Manager/Treasurer: Motion was made by Mrs. Kelly to appoint James H. Singley as Township Manager/Treasurer; motion seconded by Mr. Bennett and carried unanimously.

- RECOMMENDATION OF TREASURER'S BOND LIMIT: Motion was made G. by Mr. Bennett to recommend to the Board of Auditors that the Treasurer's Bond Limit be increased to \$500,000; motion seconded by Mrs. Kelly and carried unanimously.
- ESTABLISHMENT OF TAX RATES: Motion was made by Mrs. Kelly Η. to adopt Resolution #89-1, establishing the following tax rates for 1989:

Motion seconded by Mr. Bennett and carried unanimously.

I. PENSION EMPLOYEE CONTRIBUTIONS: Motion was made by Mrs. Kelly to adopt Resolution #89-2, resolving that Hilltown Township will not require any pension contribution from the Hilltown Township Police for the year 1989; motion seconded by Mr. Bennett and carried unanimously. Motion was made by Mr. Bennett to adopt Resolution #89-3, resolving that Hilltown Township will not require any pension contribution from the non-uniform employees for the year 1989; motion seconded by Mrs. Kelly and carried unanimously. (Mr. Bennett stated that this may be the last year the Township will not require a contribution from non-uniform personnel.)

J. PROFESSIONAL SERVICE APPOINTMENTS:

- 1) General Township Solicitor Motion was made by Mrs. Kelly to appoint the firm of Jaczun, Grabowski & Leonard as General Township Solicitor; motion seconded by Mr. Bennett and carried unanimously.
- 2) Zoning Hearing Board Solicitor Motion was made by Mr. Bennett to appoint Joseph Wagner as Zoning Hearing Board Solicitor; motion seconded by Mrs. Kelly and carried unanimously.
- 3) Engineer Motion was made by Mrs. Kelly to appoint C. Robert Wynn Associates as Township Engineer; motion seconded by Mr. Bennett and carried unanimously.
- 4) Building Inspections Motion was made by Mrs. Kelly to appoint the firm of Code Inspections, Inc. as Building Inspectors; motion seconded by Mr. Bennett and carried unanimously. Mr. Bennett stated that the Township may consider the hiring of a full-time building inspector next year, rather than an outside firm, due to the continuing growth of the Township.
- 5) Data Processing Motion was made by Chairman Grunmeier to appoint George Bock as Data Processing Consultant, subject to review by the Board of Supervisors; motion seconded by Mrs. Kelly and carried uanimously.
- 6) Depository Motion was made by Mr. Bennett to retain Union National Bank as Township Depository; motion seconded by Mrs. Kelly and carried unanimously.
- 7) Tax Collector (Special) Motion was made by Mrs. Kelly to retain Berkheimer Associates as Tax Collector for Special Collections; motion seconded by Mr. Bennett and carried unanimously.

K. BOARD VACANCIES - APPOINTMENTS:

- 1) Vacancy Board (1 year): Motion was made by Mr. Bennett to reappoint Charles Grasse to the Vacancy Board. There being no second to this motion, a motion was made by Mrs. Kelly to appoint Doris Bartl to the Vacancy Board; motion seconded by Chairman Grunmeier. Discussion followed: Mr. Bennett questioned reason for change; Chairman Grunmeier stated that it would be beneficial to the Township to have more people involved in the governmental process. A vote was taken; motion carried 2:1, with Mr. Bennett opposed, to appoint Doris Bartl to the Vacancy Board.
- 2) Parks & Recreation (5 years): Motion was made by Mrs. Kelly to appoint Ronald Allen to the Park & Recreation Board; motion seconded by Chairman Grunmeier. Discussion followed:

Mr. Bennett asked for qualifications; Chairman Grunmeier replied that Mr. Allen lives in a development and will be an asset when deciding upon satellite parks within the Township. Mr. Bennett recommended Nick Lupinacci for the position; and was informed that Mr. Lupinacci's application was received after the 12/9/88 deadline. A vote was taken; motion carried 2:1, with Mr. Bennett opposed, to appoint Ronald Allen to the Park & Recreation Board.

- 3) Water & Sewer Authority (5 years): Motion was made by Mrs. Kelly to reappoint Harry Maurer to a 5 year term on the Water & Sewer Authority; motion seconded by Mr. Bennett and carried unanimously.
- 3A) Zoning Hearing Board (3 years): Motion was made by Mrs. Kelly to reappoint Harley Moyer to a 3 year term on the Zoning Hearing Board; motion seconded by Mr. Bennett and carried unanimously.
- 4) Planning Commission (5 years): Motion was made by Mrs. Kelly to reappoint Jack Fox to a 5 year term on the Planning Commission; motion was seconded by Chairman Grunmeier and carried unanimously.
- 5) Planning Commission (5 years): Motion was made by Mr. Bennett to reappoint Kenneth Bennington to 5 year term on the Planning Commission. There being no second to this motion, a motion was made by Mrs. Kelly to appoint Carol Pierce to a 5 year term on the Planning Commission; motion seconded by Chairman followed: Mr. Bennett stated Discussion Mr. Bennington was recently re-elected as Chairman of the Planning Commission and is extremely well qualified. Chairman Grunmeier stated that the Planning Commission needs a balance of ideas and that this can be accomplished by having a woman serve on the Board. A vote was taken; motion carried 2:1, with Mr. Bennett opposed, to appoint Carol Pierce to a 5 year term on the Planning Commission. Mr. Bennington asked to speak and was told as explained previously by the Chairman, no public comment would be taken at this meeting; resident's comments will be heard at the next Supervisors' meeting on 1/9/89.
- L. SUPERVISORS' MEETING DATES: 1989 Supervisors' meeting dates were read by the Township Manager. Motion was made by Mrs. Kelly to adopt Resolution #89-4, adopting the Supervisors' meeting dates for 1989 (2nd and 4th Monday of each month at 7:30 P.M., with the exception of 2nd December meeting to be held on Tuesday, 12/26/89 due to the holiday); motion seconded by Mr. Bennett and carried unanimously.
- M. PLANNING COMMISSION MEETING DATES: Mr. Singley read the 1989 Planning Commission meeting dates. Motion was made by Mr. Bennett to adopt Resolution #89-5, adopting the P.C. regular meeting dates for 1989 to be held on the third Monday of each month at 7:30 P.M.; work sessions to be held on the first Monday of each month at 7:30 P.M. (with exception of September work session which will be held on Tuesday, 9/05/89 due to the holiday); and date of January work session to be determined; motion seconded by Mrs. Kelly and carried unanimously.

There being no further business, a motion of adjournment was made by Mrs. Kelly at 7:55 P.M. A press conference was held after the meeting to answer questions of those reporters present.
