The following bills were paid & paid amounting to \$1120.34 of Twp Funds and \$510.76 State Funds. Receipts amounted to \$1863.63 for Twp Funds and \$2154.86 to State Funds. The Supervisors decided to improve Rd No 332 with DP1 Macadam. Form 968 was prepared and sent to Ardmore, Pa approx cost of \$12,000. - 0.9 mi in length. 16ft wide. To be advertised in News-Herald for ^{bids} contracts for stone & oil. A report was made to Penna. Insprors for Loyalty Oath Forms. The meeting adjourned with a Bal in Twp Treasury of \$9714.42 and Bal in State Funds of \$3986.87 or total Bal \$13701.29.
