The Supervisors of Hilltown Twp held their monthly meeting this day with all members present, passed & paid the following bills amounting to \$1906.47. Receipts amounted to ~~766.56~~ 201.56. Bids were rec'd & opened for Asphalt Rd oil & crushed stone for 1957 Construction of approx 3 mi of macadam roads. Two bids were received for oil & 5 for stone. The low bidders were Loder & Sharp for oil and D. D. Dentine for stone, and made contract for same amount 70000 gal oil + 7500 Ton of stone. A zoning committee was appointed for Twp as follows. Mr Ed Cheuk, Mrs John Soliday, Mr. Paul F Yoder, Mrs John Murphy and Mr Howard E Boyer. Paul Yoder requested of Supervisors to share with Bond Boro in erecting a Traffic Light on #173 + County Line Rd. The board agreed to share in cost of erecting said light if Bond Boro accepts cost + responsibility of maintenance of light. The meeting adjourned with a balance in Treas. of ~~5265.77~~ <sup>\$15082.63</sup> to meet on May 7, 1957
