

HILLTOWN TOWNSHIP SUPERVISORS MEETING

April 28, 1975

The meeting was called to order by the Chairman, Dale Hartshorne. The treasurer's report was read by Mrs. Gutekunst and approved by Ferl Spanninger and seconded by Paul Frankenfield. The bills as presented were approved for payment by Feryl Spanninger and seconded by Paul Frankenfield.

After a lengthy discussion, the amendment to the dog ordinance was signed by the supervisors. However, further study is to be made on this ordinance based on suggestions from interested citizens and the Bucks County Planning Commission. Mr. and Mrs. Luedke were present at the meeting inquiring as to whether this new ordinance would be retroactive as they have quite a bit of disturbance from kennels near them. Advice was given that perhaps something could be done by them on the basis of nuisance and noise.

Mr. Leister's report on the inspection of the Wilson Property with respect to storm water runoff was read by Dale Hartshorne. Mrs. Gutekunst was asked to write a letter to Mr. Hockman and send along a copy of Mr. Leister's report relative to the possible changes which could be made when he tills his fields. Mrs. Wilson was present at the meeting and a copy of the report and blueprint prepared by Mr. Leister were given to her.

Dale Hartshorne reported that the Commonwealth Court affirmed the lower Court's decision and the Zoning Board's decision that a variance should not be granted to J. Richard Fretz. *Blue School Rd.*

Mrs. Gutekunst reported that PennDot will be resurfacing Route 113 from Kulp's Corner to Blooming Glen and that this work will begin approximately May 26th.

A notice was read of the Wastewater Management Commission meeting on Thursday, May 15th and Mr. Hartshorne will attend.

A Legal Notice of a public meeting for consideration of the Telford-Perkasie Sewer Interceptor Construction to be held on May 14th at the Telford Borough Building was read. Mr. Frankenfield will attend this meeting.

Mr. Heidrich and Mrs. Gutekunst were asked to prepare a notice for the papers asking for bids on the painting of the Township building. These bids should be asked for in two parts- inside painting and outside painting.

Mrs. Gutekunst was instructed to contact our engineers to prepare estimates and drawings on constructing dog kennels. Mrs. Gutekunst reported that we have been receiving numerous complaints on dogs running loose in the township.

The Deed of Dedication for Meadow Drive in Clearview Estates was signed and a maintenance bond of \$3500.00 was received for maintenance of 1 year.

A letter is to be written to the Board of Assessment regarding the adding and deleting of some roads from the Official Map of roads in Hilltown Township. Add Red Wing Road and Meadow Drive- delete portions of Forrest Road and Swartley Road. Mr. Frankenfield is to give Mrs. Gutekunst a copy of the township road map.

The supervisors redated and signed the subdivision plans of Wilmer Markley and the subdivision plans of Howard Garges.

Meeting adjourned.
