Bal in the Treasury is \$18614.92 in Gen Fund and \$4252.64 in S.F. or a total of \$22867.56. An ordinance was ~~proposed~~ to require all solicitors in the Twp to obtain permits, as of now the Board of Supervisors will recognize the garbage collectors till such ordinance is in effect. Eugene Egan was present at the meeting in the interest of maintaining a trailer camp in Hilltown Twp and was requested to furnish plans as called for in the Trailer Camp Ordinance formally passed. The meeting adjourned to meet on Dec 6, 1958.
