Mr John D Eberhard 3d. of Perkasie R1-Box 168 was appointed by the Board Co Court as Auditor of Hilltown Twp. To fulfill the term of Mr Joseph Cecolani who resigned and moved out of the Twp term expires in 1963. Bids were received & opened for a tractor with back hoe & front end loader two bids were received ^{from} Doylestown Agri Co and Howard H Swastly. Mr Swastly was the low bidder at a price of \$1644.00. Doylestown Agri Co had no price on bids. Said bids were held over for further study. A Representative from Barrago Auto Parts was present & purchased a junk Dealer's License at 100.00 for 1960, and a zoning book for 2.00. Mr Ralph Brown was present and was requested to furnish the Board of Lamps with 2 frames for zoning maps. D. Devonia Police was authorized to purchase Code Beam Reflector lights. The Industrial Development Committee was requested to meet at Twp Office on 3d Monday of each month at 7.30 P.M. and the zoning and justice committee to meet on the ^{1st} Monday of each month at Twp Office at 7.30 P.M. A motion was made & seconded to authorize Mr Agin to purchase a filing cabinet for use in the Twp Office. The meeting adjourned with a bal. in the Treasury of 23,906.27 in the Gen Fund and 5303.46 in State Fund or a total of 29,209.73 to meet on Dec 19th at 9. AM.
