A resolution was made by Mr Digin and by motion by Mr Frankfield was passed as follows Be it resolved that the Board of Supervisors of Hilltown Twp award a contract for Contr. of 2 Concrete Bridges on Twp Rd no 421 and said contract was signed this day by all parties concerned. Mr Ritchie Twp Eng. was present with said contract and rec'd all bids were not accepted, to return disbursements to their proper owners. The meeting adjourned to meet 16. Bal in treasury 28937.71
