## MINUTES

The meeting of the Supervisors of Hilltown Township was held this 7th day of June 1973, at the Municipal Building, 113 State St., Blooming Glen, Pa.

Mr. Frankenfield, Chairman called the meeting to order at 7:30 P.M. with all Supervisors present.

The meeting opened with the reading of the minutes of the meeting held May 19, 1973. A motion by Mr. Hartshorne to accept the minutes as read, motion seconded by Mr. Frankenfield.

The bills were reviewed and ordered paid on a motion by Mr. Hartshorne and seconded by Mr. Frankenfield.

A copy of a letter to Honorable Edwin H. Satterthwaite, President Judge, Court of Common Pleas, from Harding Longcope, that he was submitting his resignation as Constable of Hilltown Township, to become effective June 4, 1973. His resignation was due to the fact he would no longer be a resident of Hilltown Township.

The Supervisors purchased a Treasury Bill with idle funds in the amount of \$72,459.69, with an interest reate of 7.03% for a period of 180 days. We also purchased a Savings Certificate No. 3612 for 60 days, with an interest rate of 41%, from idle funds in the Liquid Fuels Account.

The Supervisors signed final subdivision plan for Robert L. Johnson, two lots, located on Diamond St.

Motion made by Mr. Hartshorne, seconded by Mr. Frankenfield.

A request from the Bucks County Planning Commission, Natural Resources Division, John T. Carson, Director, the Supervisors are to name one member of the Board of Supervisors to a working committee of the Neshaminy Basin Sewerage. On a motion by Mr. Frankenfield, Mr. Hartshorne was appointed to this committee, the motion seconded by Mr. Moyer.

The question was raised about the Police Pension Ordinance; Mr. Wilson stated he would have an answer from Mr. Jaczun for the next meeting, June 16, 1973.

We were notified from the Office of Congressman Biester, May 29, 1973, Project Announcement, Farm Home Administration has approved a loan of \$ 1,115,200 dollars to the Hilltown Township Board of Supervisors.

We received from the office of Farm Home Administration, Penrose Hallowell, State Director, payment authorization to the applicant, Hilltown Township Board of Supervisors, number of installments, 41, first installment, Jan. 1, 1975, interest rate 5%, amount of \$ 1,115,200.

The Supervisors agreed to have road inspection June 18 and 19, 1973.

We received from Titus G. Moyer, Real Estate Tax Receipts of \$ 4,593.87.

A letter was read from the Recorder of Deeds office, tax parcel number could not be listed when Real Estate Transfer checks are mailed.

A request from the Clemens Markets, May 23, 1973, for permission to place a trailer on the Shopping Center for the sale of soft ice cream, was referred to the Planning Commission to present their request.

A letter was received from the Bucks County Planning Commission dated June 7, 1973, inviting elected officers to a meeting in reference to regulations affecting all earth moving activities after July 1, 1973, meeting scheduled for 3:30 P. M. and 7:30 P.M.

The Supervisors are scheduling their annual Road Inspection.

Mr. Paul LaStada, Penna. Dept. of Traffic Engineering requested traffic accident reports for the intersections of, Route 113 and Callowhill, Blooming Glen Road and Old Bethlehem Road, and Route 313 and Broad St.

From the County of Bucks, a letter was read dated June 7, 1973 from Ms. Whiffen, a follow up of May 16, on general Revenue Sharing information. This information had been forwarded.

Our Federal Revenue Sharing Report from Jan. 1, 1973 to June 30, 1973, our share \$21,297, was advertised June 13, 1973, in the News Herald, Multi-Purpose, \$4,469, Conservation, \$1,000, Public Safety, \$5,000, and Recreation Culture, \$10,648.

Mr. Wilson, our solicitor, stated that he was in receipt of a letter from Arsen & Kaskhian, sttorney for the petitioning to rezone the tracts owned by Hillegas and Edwards, Reliance and Township Roads, to be postponed. In Mr. Wilson's opinion, we should grant this request, Mr. Kashkian will pay for the readvertising.

The Peddling License Ordinance was discussed and will be advertised, the peddling fees to remain the same.

A report was given by Mr. Hartshorne on the ground breaking ceremonies for the Joseph R. Grundy Manor, E. Lincoln Ave. and N. Washington Ave., Telford, Pa., the Supervisor's representative at the invitation of the Bucks County Housing Authority and Donald Levin, Thursday, June 14, 1973.

The Telford Post Office Ordinance will be advertised July 5, 1973.

Mrs. Edwards reported she was plagued with water and her trees were being uprooted by the water. Mr. Wilson suggested she follow the suggestion of her lawyer.

The Secretary is to call Jerry Taylor about the water pipe and drainage problems in Kennilworth development.

There being no further business, on a motion by Mr. Hartshorne and seconded by Mr. Frankenfield, the meeting adjourned at 11:00 A.M.
