The Supervisors of Hilltown Twp held their semi-monthly meeting this day with all members present. Passed & Paid the foregoing bills amounting to \$10,365.54. Receipts \$28.85. Bal in the Treasury is \$16,202.72 in Cont'd. \$2,040.98 in Gate Funds. Mr Fell was present to have County aid forms signed for Co-aid on pipes and presented them to the County Com. Mr W. P. Pichler presented a blue print of a bridge to be built next spring in place of the swinging bridge at an estimated cost of \$6,400.00. A motion was made by Mr. Agins for an amendment to a resolution passed on Dec 3 to hold the Supr. Organization on Dec 31, 1960. Said amendment changed the date to Jan 7, 1961. The auditors meeting is to be held on Jan 11, 1961 and the auditors were notified by the Sec of the date and place of meeting.
