The Supervisors of Hilltown Twp held their semi monthly meeting this day with all members present, Passed + Paid the foregoing bills amounting to 3987.36 from Gen Fund and 978.52 from State Fund or a Total of 4965.88. Receipts amounted to 8783.67. The Bal. in the Gen Fund is 19856.02 and the State Fund is ~~2242.56~~ ^{5456.94} a Total Bal in the Treasury of 22998.58. Mr Felix was present to inquire about the Hatfield street light on 308 which under the jurisdiction of Hatfield Twp. under an agreement made upon creation of a new Hat Hilltown Twp pay their share of expenses and thereafter Hatfield Twp to assume all responsibilities. Representatives of the R + S dinner were present to discuss the advisability of the Twp Board of Super drawing up an ordinance to combat disorderly conduct + put No Loitering signs at such places as is deemed necessary. Mr Agin arranged for a meeting of the Supervising Officer + the Twp Police on the evening of Thursday ^{Oct} 6 at the Twp Office to discuss the Police problems of the Twp. Mrs Lanson was present to discuss a problem of having a neighbor trailer whose sewage causes bad odors and was advised to see the County Board of Health Mr Budd norice and several other tax payers were also present. Mr Budd + Joris Heiduck of the Civic Assn were present. The Twp Engineer Mr Wm D Rutelie presented to the Board of Supervisors a plan map of the Baptist Church at Nacis Corner in course of enlarge. The Church's Cemetery and was advised to see the Twp Planning Board.
