The Semi-Monthly Meeting of the Hilltown Township Board of Supervisors was held this day with all members present. Mr. Frankfield, Presiding. The minutes of the previous meeting were read and approved. Bills amounting to \$4383.94 from the General Fund and \$501.49 from the State Funds were reviewed and ordered paid. The Treasurer's Report was read, approved as shown on financial sheet with these minutes. A discussion on the advertising shelters to be erected along the various bus stops was held, with Mr. Frankfield, recommending the Planning Commission & Zoning officer, along with the salesman of these shelters meet to make some decision. Planning Commission to make a report to Supervisors on said decision. Mr. Thomas, Chairman of the Industrial Development Comm. was present and stated his brochure was now ready for final work before mailing. A resolution transferring \$3,000.00 to Township Maint, \$2,000.00 to Twp Equipment Repairs and \$30.93 to Insurance was adopted. Said monies to be transferred from Township Road Construction. Mr. Frankfield reported to the Board the proposed Snow Removing Program for the current year as proposed by the State Highways Dept. No decision was made at this time for signing of contracts with State Highway Dept.

There being no further business, meeting adjourned to meet Dec 16, 1961, at the Township office, Rt 113, S. Leppa, Pa. at 9:00 A.M.
