The Semi-Monthly Meeting of the Hilltown  
Twp Board of Supervisors was held this day, with all  
members present. Mr. Frankfield, Presiding.

The minutes of the previous meeting was read  
& approved.

The Treasurers report showed expenditures  
from the Township Funds of \$977.80 and from the State funds  
\$768.38, leaving a balance of \$20,579.54 in the Township funds  
and \$11,486.12 in the State funds. Receipts were 77.50 for  
the Township Funds, giving a total of \$20,657.04 - Township funds.

Mr. Cooney, was present to acquire his  
Trailer Park License for 1962, ~~being~~ he informed the Board  
he would be away for the winter, but there would be a manager  
at all times at the park.

A report was read from the Secretary of the  
Industrial Development Committee, showing plenty of progress. Mr.  
Thomas, the Committee Chairman recommended that his Committee  
join the Bucks County Development Corp. at the cost of \$100.00  
for membership. A motion by Mr. Hackman, seconded by Mr. Frankfield  
for the Board to join the County organization was carried.

Mr. Ritchie, Twp Engineer was present to  
explain his position in the misunderstanding with the District Engineer.  
After hearing his side of this matter it was decided that the members  
of the Board, Mr. Ritchie & the Township Solicitor meet & get this  
matter straightened out. Secretary to notify all parties in  
question when meeting is arranged.

adjourned to meet at the Township Bldg, Rt. 113, Sept 2-1961
