

HILLTOWN TOWNSHIP SUPERVISORS

June 17, 1961

The regular semi monthly meeting of the Hilltown Township Board of Supervisors, was held this day with all members present. Mr. Frankenfield presiding.

The minutes of the previous meeting was read and approved.

The Treasurers report was presented showing expenditures from the township fund of \$164.58 and from the state fund \$2929.03. Receipts were \$387.52, leaving a balance in the township fund of \$5720.16 and the state fund \$17,079.63. A motion was made to accept the report. Motion carried.

A letter from Mr. Arthur V Shaffer, Phila, Pa, authorizing the townabhip to mow the thistle on his lot at a cost of \$5.50 per hour was discussed. after much discussion, Mr. Hockman, offered to investigate the possibility of the project.

The real estate transfer tax, which prsently is levied by the school board, was discussed. During the discussion it was pointed out that the Law states that the Board of Supervisors are entitled to 50% of this tax. Chairman Frankenfield, instructed the Secy. to contact Mr. Mountney and have him notify the School Board that the Board of Supervisorð, wish to share in tax program effective January 1. 1962.

Mr. Egan(Trailer sales agent) and Mr. Walsh(R.E. Salesman) attended the meeting requesting the board change a portion of the zoning ord. to allow Mr. Egan, to build and operate a trailer park. A lengthy discussion was held after which Chairman Frankenfield, explained this was a decision for the Zoning Board of Adjustments to make, and suggested that Mr. Egan and Me. Walsh contact the Board of Adjustments and the Township Planning Comm. for an answer to his request.

There being no further business, meeting was adjourned to meet again on July 1, 1961.
