The Regular Semi-Monthly Meeting of the Hilltown Township Board of Supervisors was held this day, Mr. Frankfield, Presiding. Those attending were Supervisors - Agin, Frankfield, & Hockman. Messrs. Peters, Derstine, Tyson, Rosenberger, Mounce.

The minutes of the previous meeting were read and approved.

Mr. Agin, presented the financial report as shown on opposite page. Motion - Hockman, seconded - Frankfield - Report accepted.

The Secretary reported on construction costs for year - Township Road 346 - Township Road - 413 - Township Road - 409 - totaling 10,560 FT AT A COST OF \$30,819.34 = OR \$1.64 sq. yard. These figures represent LABOR - \$6,566.06 - CONSTRUCTION MATERIALS - \$22,274.78 - EQUIPMENT RENTALS - \$1,678.50 - SUPPLIES - \$300.00 OR A TOTAL OF \$30,819.34.

The Secretary read a letter from the Bucks County Historical Society. The discussion period resulted in filing of said letter until a later date.

A general discussion period was had on roads, zoning, police & township problems. No action on these at the present.

There being no further business, meeting adjourned at 1:00 PM. to meet on the 15th of Dec, 9:00 A.M. at the township office.
