The Semi-Monthly Meeting of the Hilltown Township Board of Supervisors was held this day, Mr. Frankfield, Presiding. Mr. Heckman being absent because of a conflicting date. The minutes of the previous meeting were read & approved. Bills amounting to 2,522.21 were read & approved for payment. A letter from the "Neshaminy Watershed", was read, informing the Board of a proposed dam & park to be erected in the future, situate in Hilltown Township. This being news to the Board, Mr. Frankfield, instructed Mr. Agin, to write Mr. Edw. A. Miller, Exec. Director of the Watershed, an invitation to attend a meeting of the Board to explain this proposed program and its location. The report from Mr. Cowen, the Township Engineer, was read & discussed. This report was for the Evergreen Estates. The Board decided to accept the recommendations of Mr. Cowen for this sub-division. Mr. Mager, the Contractor, owner of Evergreen Estates, was present requesting signatures for this sub-division plan. These plans were discussed at length with Mr. Mager, after which Mr. Mager was informed that he could not obtain a building permit until the sub-division roads ~~had~~ had been built and he had a satisfactory Board of Health report, Mr. Mager was in accord. A motion by Mr. Agin, seconded by Mr. Frankfield, said sub-division was approved per the decision aforementioned. Mr. Mager, was also instructed to have his road profile in the Supervisors office on or before Oct 20-1962. The Industrial Development Comm. reported progress with "Bo-Mite", ~~the~~ although it seems like one problem has arisen. This being the furnishing of water. This is to be discussed with Mr. Kahn at a later date. There being no further business, meeting adjourned to meet Oct 20-1962 - 9:00 A.M. at the Township office.
