The Meeting of the Hilltown Township Board of Supervisors was held this day with all members present, Mr. Frankfield Presiding, the minutes of the previous Meeting were read & approved. Bills amounting to \$3,659.45 from the Township Funds and \$3,052.18 from the State Funds were approved and ordered paid. Mr. Agin, Reported on the cost of the Bridge on Eckerts Road, he presented the costs as follows: Engineers Fee - \$147.00, Material \$1,489.38 - Township Forces Labor \$446.90 and Equipment Rental \$8.00 or a total cost of \$2,091.28. The zoning officer Mr. Peters, presented his Report for the month of June, showing (7) Seven Building Permits issued for that period. A Resolution, adopting & approving lots 20-21-22 of the Brecki Tract, was adopted by a motion of Mr. Hickman, seconded by Mr. Frankfield. The published notice of Amendment to the Zoning Ordinance for the inclusion of a golf course in the Industrial Area was read along with the proposed Amendment. After a lengthy discussion Mr. Schenck, of the planning Commission suggested the plans for this golf course be presented by the owner, at a meeting to be held next Saturday July 14-1962. The Board feeling this was a good suggestion tabled this matter for the July 14, Meeting. There being no further business, Meeting adjourned to meet July 14-1962 - 9:00 A.M. at the Township office.
