The Regular Semi-Monthly Meeting of the Hilltown Township Board of Supervisors was held at the Township office - Mr. Hackman, Presiding.

Those attending were Messrs. Agre, Hackman, Frankenkfield & Durstine, Peters, Namoth, Tyson.

The Minutes of the previous meeting were read - motion Frankenkfield - second - Hackman accepting same.

Chief Tyson reported - 7 accidents investigated, 39 Complaints, 18 motor vehicle violations, 7-60-3 Ordinance violations, checked & investigated 4 junk yards. This represented 3254 miles traveled with 348 man hours.

Mr. Peters, zoning officer, reported 9 Permits for new homes issued for the month of July.

Mr. Agre presented the possibility of an answering service for the Township Police & Supervisors. After much discussion motion was tabled.

Mr. Rosenbly, Tax Collector gave his report. Report shows collection is behind last year.

Mr. Frankenkfield requested the Township purchase a backhoe loader before the snow season arrived. Discussion led to this motion being tabled until a later meeting.

Bills amounting to \$3601.46 from the Special fund, and \$7144.46 from the State funds were read. Motion - Hackman seconded - Frankenkfield - authorizing payment of same.

There being no further business, meeting adjourned 1:45 P.M.
