The Regular Semi-Monthly meeting of The Hilltown Township Board of Supervisors was called to order by the Chairman, Mr. Frankfield. Those attending were Supervisors Agin, Frankfield & Hackman.

The minutes of the previous meeting were read and unanimously approved.

Bills amounting to \$2,182.68 from the general fund were approved and ordered paid.

A letter from Mr. Daniel Coll, Secy of the Sellersville Fire Co, Fireman's relief association was read, letter being a request for sharing of the Foreign Fire insurance refund with Selbottle. After a lengthy discussion, the Secretary was instructed to write Mr. Coll a letter explaining the reasons the Board have refused this request. This brought up a discussion on contributions to the seven (7) fire companies that serve the Township. A motion by Mr. Frankfield - seconded - Agin to send a donation of \$100.00 to each company for general expenditures.

Plans for the STRATA Property were presented for signatures, motion by Agin, seconded Hackman, plans unanimously approved. including lots 1 to 11, 14 to 17 + 20-21

Mr. Agin, requested a Double arrow Warning sign & Red Warning signals installed along middle road & the intersection of Fritz Road. Request approved.

General discussion was had with no immediate action.

With no further Business on the agenda, meeting adjourned to meet March 2 - 1963
