Motion was made by Mr. Nogami, seconded by Mr. Sichelstiel, and carried unanimously to recommend approval for the Hilltown Baptist Church Land Development Waiver contingent upon the items contained in Wynn Associates Inc. review letter dated August 29, 2023. There was no public comment.
